The above named individual does hereby state and affirm that he/she will abide the terms and conditions of this agreement. Perfect Pets Rescue (PPR) believes this animal to be in good physical condition; however, PPR does not guarantee the health of any animal released for adoption. We have taken the animal to a veterinarian for vaccination and spay/neuter as required by PPR and by state and county law.

THE ABOVE NAMED INDIVIDUAL AGREES TO THE FOLLOWING

I hereby take this animal in its present condition and agree to care for it in the most humane manner and in accordance with this agreement. I will not use this animal for vivisection or sell this animal for vivisection. I am willing to allow for investigation of the animal 's welfare by one of PPR's authorized agents at any given time. If PPR determines that the adoptive parent is not in compliance with PPR policy regarding humane treatment or that the above named individual is not in compliance with this contract, the adopting party agrees to surrender the animal immediately upon request to PPR. I understand that I may not give the animal to another party and that I cannot be released from responsibility and liability for this animal unless I return the animal to the Perfect Pets Rescue authorized agent. If the adoption does not work out, I will return the animal to PPR. In the case of a return, I must speak personally to the PPR authorized agent and give a minimum 4-day prior notice of returning the animal. If the animal dies, only signed verification by a licensed veterinarian mailed to *and received by* Perfect Pets Rescue will release me from responsibility

and liability of this contract. *I understand that \$50 of the adoption fee is non-refundable if I choose not to adopt the pet within 3 days of this contract and is completely non-refundable once I take possession of the pet even if I decide to return him/her.*

I also understand that I am accepting this animal AS IS. I have been told of any KNOWN CONDITIONS and accept responsibility for veterinary care of this animal should it required medical care in the future. I also agree to the following special conditions: Puppies (to age 6 months) will be supervised at all times while outdoors. Animals will not be tethered (chained or tied up) at any time. Animals will not live outside. Animals will wear an ID tag at all times. Animals will be given Heartworm Preventative on a monthly basis. If an unspayed, female dog is/becomes pregnant the puppies are property of PPR, Inc.

An adoption donation of \$ 400/350 will be made at the time of adoption. The adopter agrees that he/she will under NO CIRCUMSTANCES reverse payment or cancel the check made out to PPR. There is a returned check fee of \$30.

PPR has the right to reclaim the dog if the adopter violates any of these terms.

THE ADOPTER(S) AGREES TO INDEMNIFY AND HOLD HARMLESS Perfect Pets Rescue, Inc. , IT'S MEMBERS AND VOLUNTEERS, FROM ANY AND ALL CLAIMS, CAUSES OF ACTION,OR DAMAGES , WHETHER KNOWN OR UNKNOWN, ANTICIPATED OR UNANTICIPATED RELATING TO THIS ANIMAL (S), OR ARISING OUT OF THE CONDUCT OF THIS ANIMAL (S) ON OR AFTER.
